PENSION ADALAT-2023

Pensioners/Family Pensioners having grievances relating to Pension and other retirement related benefits covered under CCS(Pension) Rules, 1972 of following cases may submit their application in the prescribed format (Annexure A) on or before 12th September, 2023 for redressal of grievances in the Pension Adalat to be held on 20th September 2023 at 11.00 Hours at Jawaharlal Nehru Custom House, Mumbai Customs, Zone- II, Nhava Sheva.

Cases of retirement on superannuation till 30.06.2023 in which PPO's have not been issued till date.

- i. Cases of voluntary retirement till 31.03.2023 in which PPO's have not been issued till date.
 - ii. Cases of death of Government servants till 31.03.2023 in which family pension has not been sanctioned till date.
 - iii. Cases of death of Government servants in the performance of duty till 31.03.2023 in which only provisional/ordinary family pension has been sanctioned and family pension under CCS(EOP) Rules has been claimed.
 - iv. Cases wherein Death Certificate of the pensioner has been submitted to Pension Disbursing Bank and Family Pension not started within one month of receipt by the bank if the name of the Family Pensioner is given in the PPO.
2. Following types of grievances/cases shall not be entertained in the Pension Adalat:
- (i) Cases involving purely legal point e.g. Succession etc.
 - (ii) Grievances involving Policy matters
 - (iii) Issues like appointment on compassionate ground
 - (iv) Retention of quarters after retirement and Recovery of Penal/damage rent relating thereto
 - (v) Any other issue not found lying within the domain of Pension Adalat in terms of Office Memorandum dated 09.02.2015 F.No.C30013/77/2014-Ad IV. A) Read with Office Memorandum dated 25.03.2011 of DOPPW (F.No.44013/2/2010-Coord.)
3. The staff who retired from Jawaharlal Nehru Custom House, Mumbai Customs, Zone- II, Nhava Sheva may send their application/ grievances in prescribed format.
4. Notification and format of application may also be downloaded from the Pension Adalat Page on official website of Mumbai Customs, Zone- II.
5. Any application/grievances received after 12th September, 2023 shall not be considered for redressal in the proposed Pension Adalat 20th September 2023.
