Sub: Implementation of Risk Management System (RMS) for DEPB Clearances Reg.

Attention of all Importers, Custom House Agents (CHA) and the members of the Trade is invited to P. N. No.12 / 2006 dated 17.02.2006 regarding implementation of the RMS for Imports other than those under various export promotion schemes. It has now been decided to extend the RMS module for the import clearances to the DEPB scheme. The guidelines for implementing the RMS for the clearances under DEPB scheme are given below:

2. The implementation of the RMS module in respect of DEPB clearances will be effective from 21.05.2007.

3 In respect of DEPB Scrips issued prior to 12.03.2007, i.e. prior to online transmission of DEPB Scrips, the Importers/CHAs will continue to be required to register the DEPB scrip/Release Advices with the DEPB

Registration section and Registration Number will then be issued, which should be quoted in appropriate column of the Bill of Entry. In respect of online transmission of Scrips, the Importers/CHAs will be required to quote the DEPB Licence no. at the time of filling the Bills of Entry.

- Bill of Entry and the Import General Manifest (IGM) will continue to be filled electronically in the ICES either through the Service Centre or through the ICEGATE. The RMS will then generate the treatment code for the Bill of Entry based on risk parameters and intelligence received. The output in the form of treatment code along with the appraising/ examination instructions would be conveyed to the concerned officer as is being presently done in respect of Bills of Entry covered by RMS (Gr. I to Gr. VI).
- In case of non-facilitated Bills of Entry, the procedure for assessment as followed in respect of RMS assessed Bill of Entry (Gr. I to Gr. VI) would continue to be followed. The Appraising Officer of the concerned Group will assess the Bill of Entry forwarded to him as is being presently done, aided with the RMS generated set of Appraising Instructions and incorporating the examination instructions in the examination order. The Appraising Officer of the group will examine the debit made in the licence in the system and shall also endorse the hard copy of the Licence.
- 6. In respect of facilitated Bills of Entry, the DEPB debit in the System will be examined by the newly created DEPB (RMS-Debit) Section, under the Import Commissionerate which shall also endorse the hard copy of the licence. Same procedure shall be applicable for verification of the Bills of Entry which are only marked for examination.
- 7. As regards procedures such as amendments to IGM/BE, PCA, C.C.R.s, Examination etc., the same would in the manner as is being done in respect of Non-DEPB clearances which are already under RMS.

8. Where it is necessary to submit various bonds, U/Ts, miscellaneous certificates, permits etc with regards

to any notification benefit or in fulfillment of conditions of certain allied Acts, the same will be verified

physically and debited manually by the appraiser of concerned group in respect of non facilitated Bills of

entry and by the Out of Charge Officer in case of facilitated Bills of Entry and the Bills of Entry selected only

for examination. The said out of charge officer would at the same time also verify that the necessary bond /

miscellaneous certificate details have been declared in the system by the Importer/CHA at the time of filing

of the Bill of Entry.

9. All other aspects of clearances will be governed by the Public Notice No 12/2006 dt. 17.02.2006 issued

by Commissioner of Customs (Imports), Jawaharlal Nehru Custom House which deals with the

implementation of RMS in Imports.

10. In case any difficulties are faced in respect of such DEPB clearances the trade may contact the

Joint Commissioner of Customs (LRM) at the stated address.
