- 2. The new procedure to be followed is detailed below.

The importer /CHA will get the forwarding from the AO and ensure that the containers are grounded and are ready for inspection and examination. After that he will approach the AO for registration in respect of the B/E which will be done during timings specified below. After registration the AO/EO will conduct examination of the goods immediately in the same time cycle. Soon after completing the round of examination the AO/EO will feed the examination report and give Out of Charge, if otherwise in order. After completion of one cycle in CFSs

mentioned at Sr. No. 1 to 11 in para 1 above, the AO will again take up the registration of the B/E, examination and reporting as per the next time cycle as given below in Table- I.

3. In respect of CFS mentioned at Sr. No. 12 to 21 (except those at Sr. No. 13 and 21) in para 1 above, the time cycle as per Table - II below shall be observed as far as possible. However, to avoid delay and depending upon the work pressure, the AO/Supdt. holding charge of more than one CFS may register all the documents pertaining to his charge at any of the CFS under his charge. The time allotted for examination of the cargo at individual CFS may also be flexibly used depending on the load factor.
