**PUBLIC NOTICE 15 /2008**  
**(Referred / amended vide P.N.No. [128/2010](#))**

**Sub: -** Taking of Bank Guarantees (B/G) in cases of Notifications pertaining to conditional re-exportation of imported goods of containers of durable nature (Nfn.No.104/94 Cus.), goods manufactured in India and parts of Such goods whether from/of Indian origin/foreign manufacture and re-imported into India for repairs or for re-conditioning, or processing, or refining, or remaking etc. (Notfn. No.158/95 Cus.) and re imported goods exported under various export promotion schemes (Notfn No. 094/96 Cus. )etc – procedure regarding.

Attention of all importers/exporters/CHAs and general trade is invited on the above subject.

The following types of Bank Guarantees along with PD / Transit Bonds (End Use Bonds) will be resorted to be taken in this Custom House :-

i) In case of first time importer, the B/G of 25% of differential duty i.e of duty exempted shall be taken.

**ii)** in case of regular importers including 2<sup>nd</sup> import of para (i) above , wherein submission of no such re-export proof is pending with the Assessing Group beyond permissible limit, no B/G shall be taken.

**iii)** In case of regular importers including 2<sup>nd</sup> import of para (i) above, wherein submission of re-export proof within stipulated period is pending with the Assessing Group in previous cases, then B/G of 10 % of differential duty shall be taken.

**iv)** In case of importers who have not complied with the terms of bonds in previous importations within stipulated period pending in the Assessing Group, 25 % B/G of the differential duty shall be taken.
