In addition, the fields like Anti Dumping Duty, Cess, TTA, Health CVD, NCD Duty, Safeguard Duty, Scd 2 Spl Exc Duty and GSIA have also been incorporated. The copy of the said format of Manual Bill of Entry in Legal size paper is attached herewith.

3. The members of the trade, if they so desire, may use the new format for filing Manual Bill of Entry in JNCH, Nhava Sheva.

4. Difficulties faced, if any, may be brought to the notice of the ADC, CCO, JNCH.
