#### Sub: Clearance of Baggage at Unaccompanied Baggage Centre,

#### J.N. Custom House, Nhava Sheva reg.

Attention of all CHAs /CFS Custodians/ Shipping Lines and their agents/ NVOCCs / Freight Forwarders are invited to the <u>Public Notice No. 13/2010</u> dated 10.02.2010 interalia directing the Shipping Agents to transfer LCL cargo of personal effects landed at various CFSs to Speedy CFS, Sonari Village, Nhava Sheva under Preventive supervision.

2. It has been represented by the passengers and their authorized CHAs that they have been facing inconveniences in getting the LCL baggage cargo shifted from various CFS to Speedy CFS besides bearing an extra monetary burden.

3. The representation made by the CHAs has been examined and it is decided that Non-Vessel Operator Container Carriers (NVOCCs) and Freight Forwarders (FFs) will henceforth file their Sub-IGMs simultaneously with the filing of main IGM by the Shipping Agents facilitating the latter to identify the containers of LCL cargo containing personal effects/ baggage cargo at the time of off-loading from the vessels. Therefore, all the Shipping Lines and their Shipping Agents are directed to shift such LCL containers (which contain baggage/ personal effects and also cargo of other importers) directly from Port to U.B. C. at Speedy CFS, Sonari Village only.

4. The management of Speedy CFS is also directed to destuff such containers immediately on its receipt and keep the cargo in their warehouse for eventual delivery to the Consignees and the passengers and such destuffed containers shall not be used for storage of the goods.
