In view of the above it is once again reiterated that all the Steamer Agents/ Carrier Agents/Console Agent/Carry Agencies must get their details verified/updated in the Carrier Agents Directory failing which they will not be allowed to transact any business in the EDI 1.0 Version or 1.5 Version. So It is also to inform that action will also be initiated against them under the provisions of Customs Act 1962 or any other law for time being in force.
