**Subject : Filing of Manual Shipping Bills during migration**

**From ICES 1.0 to 1.5**

Attention of all exporters, Custom House Agents and members of Trade and all other concerned is invited to the fact that ICES 1.5 is being launched from 5<sup>th</sup> April, 2011 at Nhava Sheva. As a preparatory measure, the EDI system in ICES 1.0 will not work from 1<sup>st</sup> April to 4<sup>th</sup> April. Therefore shipping bills will not be processed in EDI. However, in order to facilitate trade, in exceptional circumstances, exports would be allowed on filing of manual shipping bills. The permission for filing manual shipping bill will be given by the Commissioner(Export) only in urgent cases. Trade is advised not to file manual shipping bills as far as possible as it may create problem like claiming of export benefits, transmission of shipping bill to DGFT etc.

2. At present facility of filing of manual S/B is allowed at CWC CFS Dronagiri as per [Public Notice 01/2011](#). The same procedure will be followed by the exporters for the manual shipping bill during the migration period from 1<sup>st</sup> April to 4<sup>th</sup> April. Noting of manual shipping bill could be allowed only at said CFS.

3. It is further informed that due to migration the system will be closed from 1<sup>st</sup> April, 2011. Therefore, all stakeholders are advised to complete the export formality and register the goods by 12.00noon on 1<sup>st</sup> April, 2011. The feeding of examination report and LEO will be completed by 4 p.m on that day. However in exceptional circumstances, if exporter is expecting some urgent cargo to be shipped after 1<sup>st</sup> April then he is advised to file advance shipping bill and get it assessed from the proper officer.

4. Any difficulty, if faced, in the implementation of this Public Notice may be brought to the notice of the undersigned.
