**Sub: Re-constitution of “Permanent Trade Facilitation Committee (PTFC)” for NS-Gen, NS-II and NS-IV Customs Commissionerates, JNCH – Reg.**

Attention of all the Exporters, Customs Brokers and the Members of the Trade is invited to the Public Notice No. 59/2010 dated 25.06.2010 on the above subject.

**2. The following are the present members of the PTFC (Export).**

- q) Regional Manager of Central Warehousing Corporation (CWC), Nhava Sheva to represent all CWC run CFSs and transshipment Cargo Carrier

As a trade facilitation measures and providing “Ease of Doing Business” and to effectively address various problems faced by the Trade and Industry in the Customs clearance with other allied agencies and stake holders, it has been decided to re-constitute the PTFC by including various associations/stake holders who are presently not represented in the PTFC.

All the Trade & Public, other connected institutions/associations/stake holders other than already nominated and are willing to participate in the Monthly PTFC Meeting are therefore, requested to send their willingness to the Asst. Commissioner of Customs (Appg)(Main)(Export), JNCH, Nhava Sheva on or before 30.4.2016 so that a new Committee could be re-constituted.
