## Subject: Clarification regarding holding window period post 00:00 hrs of 13.04.2020 by Port/Terminals for allowing delivery of DPD-DPD containers to importers at Port / Terminal gates - PN 48/2020 dated 08.04.2020 and 51/2020 dated 09.04.2020 regarding

Attention of Importers, Customs Brokers, Custodians including CFSs, Trade, Jawaharlal Nehru Port Trust (JNPT), Terminal Operators at JNPT, Shipping Lines / Shipping Agents and other stakeholders is invited to PN 48/2020 dated 08.04.2020 and 51/2020 dated 09.04.2020 issued, inter alia, so as to keep speedy evacuation of DPD-DPD containers with rail facility and last mile connectivity by road by CONCOR, and whereby the DPD-DPD procedure stands temporarily revised.

2. A query has been received whether after 00:00 hrs of 13.04.2020, the window of minimum 48 hours presently available to DPD-DPD client for taking delivery of its DPD-DPD containers from Port/Terminal gate shall continue to be available.

3. In this context it is noted that said PNs have been issued in advance and for making temporary change in extant procedure from a prospective date whereby the movement of DPD-DPD containers from JN Ports / Terminals to CFSs is stopped. The 72-hour period specified till 00:00 hrs of 13.04.2020 in the PNs is a facilitation by way of extended window for direct delivery to importer recognizing that there is a changeover period. The said PNs do not specify stoppage of the cycle of minimum 48 hours (or other higher period specified by Port/Terminals) which Ports/Terminals provide as window to DPD-DPD importers to take delivery at the Port/Terminal gates. It is clarified accordingly.
