All Cargo Logistics Limited-Koproli until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provision of Chapter VIII of the Customs Act, 1962 and for the Export Cargo brought into said Container Freight Station, for examination and stuffing till their exportation through Jawaharlal Nehru Port. The Custodianship was extended from time to time and last extension was granted for a period of 05 (five) years from 12.03.2015 vide Notification No. 16/2015 dated 06.04.2015.

3. Whereas, the Vice President of the CFS M/s. All Cargo Logistics Limited- Koproli vide letter 12.04.2019 had requested for de-notification of the CFS citing the reasons of changing business scenario and as also they are further planning to convert CFS into a warehousing facility to consolidate their business.
