Kind reference is invited to Board's Instruction No. 31/2022 – Customs dated 14.11.2022 issued from file F.No.401/66/2022-Cus-III, along with the Order issued by the Food Safety and Standards Authority of India (copy enclosed) vide F. No. TICB05/5/2022-IMPORTS-FSSAI dated 17.10.2022 on the above-cited subject.

2. Vide the above-mentioned Order dated 17.10.2022, FSSAI has decided that with effect from 1st February 2023, import of below specified high-risk products shall be permitted only through 61 ports (copy attached), which are directly manned and managed by the FSSAI office/Officials. The list of such high-risk food products is as specified below:

- i. Milk and Milk Products.
- ii. Egg powder.
- iii. Meat and Meat Products, including Poultry, Fish and their products.
- iv. Food for infant nutrition / Infant Foods.
- Nutraceuticals, Health supplements, Food for Dietary uses, Probiotic and prebiotic foods, and Foods for Special Medical Purposes.

3. In this regard, FSSAI has sought comments / Suggestions to facilitate ease of doing business while ensuring the mandate of safe food import in India within 30 days from the date of publication of that order at email id – *dramit.sharma@fssai.gov.in* and *imports@fssai.gov.in*

Vide order dated 17.10.2022 FSSAI has decided that with effect from 1st February, 2023, import of below specified high-risk products shall be permitted only through 61 ports (copy attached), which are directly manned and managed by FSSAI office/officials. The list of such high-risk food products is as specified below:-

(i) Milk and Milk Products;

(ii) Egg powder.

(iii) Meat and Meat Products including Poultry, Fish and their products.

(iv) Food for Infant nutrition / Infant Foods.

(v) Nutraceuticals. Health supplements, Food for Dietary uses. Probiotic and

prebiotic foods. Foods for Special Medical Purpose.

Sub: Restricted entry of food items in under specific ports-reg

In pursuance of Section 25, Chapter V of Food Safety and Standards Act, empowering Food Safety and Standards Authority of India to regulate and ensure the safety of food being imported in the country and to envisage a robust import control system ensuring efficient monitoring and traceability of high risk products, it has been decided that import of high risk products as specified below shall be permitted through 61 ports only which are directly manned and managed by FSSAI office/officials (list of port enclosed). The list of such high food products is as below:

- Milk and Milk products, i.
- Egg powder, ii.
- Meat and Meat products including poultry. fish and their products. iii
- Foods for Infant nutrition/ Infant Foods. iv.
- Nutraceuticals. Health supplements. Foods for Dietary uses. Probiotic and ١. prebiotic foods, Foods for Special Medical Purposes.

To further facilitate ease of doing business while ensuring the mandate of safe food imports in India, comments/suggestions are invited from all the stakeholders in this regard within 30 days from the date of publication of this order at e.mail :dramit.sharma@fssai.gov.in : imports@fssai.gov.in.
