EDI System – reg.**

Attention of all Importers/Exporters, Customs Brokers and other stakeholders is invited to D.G. System, ICES, Advisory No. 24/2022 dated 28.12.2022 (copy enclosed), on the above subject.

- Reference is invited to CBIC Notification No. 112/2022- Customs (N.T.) dated 22.12.2022 notifying Customs Tariff (Determination of Origin of Goods under the India-Australia Economic Cooperation and Trade Agreement) Rules, 2022 which came in force w.e.f. 29th December 2022 and to CBIC Notification No. 62/2022-Customs dated 26th December 2022 notifying the Customs duty exemptions applicable on such imports on satisfying the conditions mentioned therein w.e.f. 29th December 2022.
- The above Notifications have been implemented in the System. The manner of claiming the benefits under the above Tariff Notification is explained in the ICES Advisory No. 24/2022 dated 28.12.2022.
- The above changes have come into effect from 29th December 2022 for the Bill of Entry and Shipping Bill filed in the Customs EDI System. Trade and other stakeholders are advised to refer to the above changes for filing the Bills of Entry and Shipping Bill w.e.f. 29.12.2022.
- This Public Notice should be considered as a Standing Order for the concerned Officers and Staff of Customs JNCH.
