Customs Preventive Officer at the In Gate of CFS of JNP, presently being managed by M/s Speedy Transport Pvt. Ltd., shall maintain a register as per the Annexure I and enter the Container Code Number, as endorsed by M/s Speedy Transport Pvt. Ltd. officials at JNP Buffer Yard, Sheva, with time and date while countersigning the endorsement regarding seal, on the reverse of the Invoice. Container Code No. is on yearly basis and starting from the beginning of the Calendar year.

When the Shipping Bill is passed and Let Export Order has been given, M/s Speedy Transport Pvt. Ltd. officials at JNP, Buffer Yard, Sheva, will take necessary steps to move the container after completion of the formalities. The time and date of outward movement of the Containers from JNP, Buffer Yard, shall be endorsed on the Shipping Bill by the authorised officer of M/s Speedy Transport Pvt. Ltd. It should be

ensured that there is no undue delay in transit from JNP, Buffer Yard to Container Yard inside the JNP and in case the container reaches the Container Gate of JNP / NSICT after two hours of the Buffer Yard outward time noted, then M/s Speedy Transport Pvt. Ltd. officials at the container yard shall not permit the entry of such containers without taking NOC from Customs Preventive Officer posted at the Container Gate. The Customs Preventive Officer at the Container Gate shall enter the details in a separate register as per Annexure • II for containers received from JNP, Buffer Yard. He shall also ensure that the containers have reached the Container Gate within two hours and in case of any delay should call for explanation from Speedy Transport Pvt. Ltd. and take Instructions from the A. C. P. (G.). The authorized person of M/s Speedy Transport Pvt. Ltd., at JNP Buffer Yard shall also give a weekly report on every Tuesday to Assistant Commissioner of Customs, (Export), in-charge JNP, CFS giving details of the containers received at the Buffer Yard. They shall also give a list of containers which are lying at the Buffer Yard for a period of more than five days. With the issue of this Standing Order, the earlier Standing Order dated 29.03.2001 and Standing Order No. 271 / 1997 dated 07.07.1997 stands rescinded.

Noncompliance of the above instructions shall be viewed seriously.
