STANDING ORDER NO. - 22 /2023

Subject: Guidelines for Re-testing of samples in CRCL, New Delhi- reg.

Reference is drawn to Board Circular 30/2017-Cus dated 18.07.2017 prescribing detailed guidelines for retesting of samples and subsequent Public Notice No. 97/2017 dated 28.07.2017 issued by JNCH in this regard.

- 2. In this regard, it is observed that while forwarding the samples to CRCL, Delhi, documents such as letter from the forwarding authority, re-test fee Challan for 250/- and initial test report, are not being forwarded to CRCL, Delhi in prescribed format which is resulting in significant delay in retesting of samples.
- 3. In order to expedite and streamline the procedure of retesting of samples, all mandatory documents like, approval of competent authority, re-test fee Challan for 250/- and initial test report, as prescribed in CRCL Manual must be enclosed along with the letter from the forwarding authority (Jurisdictional Additional Commissioner/ Joint Commissioner while forwarding samples for retesting at CRCL, Delhi. It may also be specifically mentioned in the letter to CRCL whether the consignments is "Live".
- 4. This Standing Order shall come into force with immediate effect and any difficulty in the implementation of the above-said directions may be communicated to the Commissioner of Customs, NS-I, JNCH.
