Subject: Policy for Transfer/Rotation in the grade of Superintendents of Customs (Preventive) and Inspectors (Preventive Officers) at Mumbai Customs Zone II, Nhava Sheva-reg.

Attention is invited to the Standing Order NO. 13/2019 dated 02.07.2019 issued vide F. NO. S/43-Gen-102/2018-19/PSO/JNCH on the above subject as modified vide Standing Order No. 08/2022 dated 12.07.2022 & S.O. 27 of 2023 dated 22.11.2023.

2. In partial modification to the above Standing Order in respect of the transfers/postings of Superintendents of Customs(P) (Group B Executive Gazetted) and Inspector (Preventive Officer) (Group B Non-Gazetted), the following guidelines are incorporated as below:
