Therefore, in exercise of the powers conferred on me by section 8(a) of the Customs Act, 1962, I, Manoj Krishna, Commissioner of Customs (Export), Jawaharlal Nehru Custom House, Mumbai, Zone II, Nhava Sheva hereby re-notify an area of 27773.04 Sq.Meters of Container Freight Statin, M/s Navkar Corporation located at Vill.-Somathane, Taluka-panvel, Distt.- Raigad, Maharashtra for Rail Terminal.

Now, therefore the total area of 104387.50 Sq.
