## **NOTIFICATION NO. 04 / 2016**

The area measuring approx. 60878 SQM of Container Freight Station of M/s. Apollo Logisolutions Ltd. located at Somathane Village, Taluka Panvel, Maharashtra was declared as a 'Customs Area' under Section 8 of the Customs Act, 1962 vide Notification No. 15 /2009 dated 30.07.2009. M/s. Apollo Logisolutions Ltd. was appointed as a Custodian for that area under Section 45 of the Customs Act, 1962 vide Notification No. 16/2009 dated 30.07.2009, issued from F. No. S/5-Gen-17/2006 P & E, Pt. II, JNCH. Further, under the provisions of Regulation 10 of the "Handling of Cargo in Customs Areas Regulations, 2009" M/s. Apollo Logisolutions Ltd. was approved as a "Customs Cargo Service Provider" for the said Container Freight Station for a period of two years vide aforementioned Notification No. 16/2009 dated 30.07.2009. The appointment of M/s. Apollo Logisolutions as Custodian under Section 45 of the Customs Act, 1962 and as Customs Cargo Service Provider under the provisions of Regulation 10 of HCCAR, 2009 was further extended for a period of five years vide Notification No. 8/2011 dtd. 29.07.2011 issued from F.No. S/5-Gen-17/2006 P & E, Pt. II, JNCH.

- 2. An additional area of 20339 SQM. of M/s. Apollo Logisolutions Ltd. was notified as a 'Customs Area' under Section 8 of the Customs Act, 1962 vide Notification No. 14/2015 dated 31.03.2015 issued from F.No. S/5-Gen-99/2014 CFS M. Cell. M/s. Apollo Logisolutions Ltd. was appointed as Custodian under Section 45 of the Customs Act, 1962 for the entire area of 81,217 Sq. M. of CFS M/s. Apollo Logisolutions Ltd. vide Notification No.15/2015 dtd. 31.03.2015 issued from F.No. S/5-Gen-99/2014 CFS M. Cell. Further, M/s. Apollo Logisolutions Ltd. was appointed as Customs Cargo Service Provider for Customs Area of CFS under the provisions of Regulation 10 of the HCCAR, 2009 vide aforesaid Notification No. 15/2015 dtd. 31.03.2015.
- 3. Now, in exercise of the powers conferred on me under Section 45 (1) and 141 (2) of the Customs Act, 1962, I, Subhash Agrawal, Commissioner of Customs (General),

Jawaharlal Nehru Custom House, Mumbai Zone II, Nhava Sheva, hereby appoint M/s. Apollo Logisolutions Ltd. to be the 'Custodian' of the imported goods received at the Container Freight Station of M/s. Apollo Logisolutions Ltd. until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provisions of Chapter VIII of the Customs Act, 1962 for the entire Customs Area of 81,217 SQM. Similarly, M/s. Apollo Logisolutions Ltd. will also be the 'Custodian' of the Export cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port.

- **4.** Further, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Area Regulations, 2009", I, Subhash Agrawal, Commissioner of Customs (General), hereby approve M/s. Apollo Logisolutions Ltd. as a "Customs Cargo Service Provider" for the entire Customs Area of 81,217 Sq. Mtr. of the CFS M/s. Apollo Logisolutions Ltd. subject to following conditions
  - (i) The Custodian M/s. Apollo Logisolutions Ltd. approved as Customs cargo Service Provider for the said CFS shall abide by all the provisions of the Customs Act, 1962 and the Rules of the "Handling of Cargo in Customs Area Regulations, 2009", other Regulations, Notifications, Orders issued there under.
  - (ii) The duration of the appointment of M/s. Apollo Logisolutions Ltd. as 'Custodian' and as "Customs Cargo Service Provider" shall remain for five (5) years from 31.07.2016 unless otherwise suspended/revoked/cancelled prior to the expiry of the said period.
  - (iii)As and when required, the CCSP should provide office space for scanning of Import/Export documents.
- (iv)The Commissioner of Customs (General) shall have the right to review the approval as 'Customs Cargo Service Provider' before the completion of five years for failure to comply with the provisions of the Customs Act,1962 in general and/or of "Handling of Cargo in Customs Area Regulations, 2009"in particular.
