- 4. The service provider should have sound knowledge of the website related operations and experience of operating the same.

- 5. The select service provider will be responsible for updating the website for 01 year from the date of operation.
- 6. The payment shall be made only after completing and operation of the work.
- 7. The time limit for completion of any assignment given by the department will be adhered to by the service provider.
