Whereas 800 metres of quay, approach trestle Nos. 1, 2 & 3 and corresponding backyard of M/s. Bharat Mumbai Container Terminals located at J. N. Port, Village Nhava Sheva, Taluka Uran, Distt. Raigad, Maharashtra, was notified as the 'Customs Area' under the provisions of the Section 8 of the Customs Act, 1962 vide Notification Nos. 04/2017 dated 25.05.2017, 12/2017 dated 29.09.2017 and 16/2017 dated 29.11.2017. An additional quay length of 200 metres, approach trestle Nos. 04 & 05 and corresponding backyard located adjacent to the abovementioned 800 mtrs quay has been developed as mentioned in the schedule below for their operations.

- 2. Therefore, in exercise of the powers conferred on me under Section 8(a) of the Customs Act, 1962, I, M. R. Mohanty, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Nhava Sheva, hereby notify the said 200 metres of quay, approach trestles Nos. 04 & 05 and corresponding backyard of M/s. Bharat Mumbai Container Terminals located at J. N. Port, Village Nhava Sheva, Taluka Uran, Distt. Raigad, Maharashtra, as a place for unloading of imported goods and for loading of export goods subject to the strict observance of the provisions of the Customs Act, 1962 and other instructions issued in this behalf by the Government of India or the Commissioner of Customs (NS-General), Jawaharlal Nehru Customs House, from time to time.
- 3. Further, under Section 8(b) of the Customs Act, 1962, I, M. R. Mohanty Commissioner of Customs (General) hereby specify the limits of the Customs Area comprising the above 200 metres of quay, approach trestle Nos. 04 & 05 and corresponding backyard of M/s. Bharat Mumbai Container Terminals under J.N.P.T, Nhava Sheva, located at Village Nhava Sheva, Taluka Uran, Distt. Raigad, Maharashtra, as under:
