*(ii)(a) I hold that the impugned goods covered under Bills of Entry mentioned in Annexure-B, having total declared assessable value of Rs. 8,34,30,509/- (Rupees Eight Crores Thirty-Four Lakh Thirty Thousand Five Hundred Nine Only) are liable to confiscation under Section 111(m) of the Customs Act, 1962.*

*However, I do not impose any redemption fine under Section 125(1) of the Customs Act, 1962, for the reasons cited supra."*

*(ii)(a) I hold that the impugned goods covered under Bills of Entry mentioned in Annexure-B, having total declared assessable value of Rs. 4,07,90,666/- (Rupees Four Crores Seven Lakh Ninety Thousand Six Hundred Sixty-Six Only) are liable to confiscation under Section 111(m) of the Customs Act, 1962.*

*However, I do not impose any redemption fine under Section 125(1) of the Customs Act, 1962, for the reasons cited supra."*
