Public Notice No. 14 /2026

Attention of Importers, Exporters, Customs Brokers, Liners, Freight Forwarders, Console Agents and all other Stakeholders is invited to the **Public Notice No. 12/2026 dt. 20.01.2026** notifying change in location of Container Freight Station M/s Hind Terminals Private Limited to **Kalambusare Chirner Road, Chirner Village, Tal. Uran, Dist. Raigad, Maharashtra-410206** and **Public Notice No. 13 / 2026 dt. 20.01.2026** appointing M/s Hind Terminals Private Limited as Custodian under Section 45(1) and 141(2) of the Customs Act, 1962 and Customs Cargo Service Provider (CCSP) under Regulation 10 of the Handling of Cargo in Customs Area Regulations 2009.

2. In this regard, it is informed that the movement of imported, export and transshipment cargo to/from the existing facility of the CFS M/s Hind Terminals Private Limited at Palaspe, Mumbai Goa Highway, Taluka- Panvel, Dist. Raigad from/to the port shall be stopped from 01.02.2026.

3. The imported and export cargo lying in the existing CFS M/s Hind Terminals Private Limited at Palaspe, Mumbai Goa Highway, Taluka- Panvel, Dist. Raigad as on 01.02.2026 will be cleared from the existing CFS till 15.02.2026. The CCSP shall make all necessary arrangements to enable examination and clearance operations at both locations viz. at Chirner and Palaspe, during the period from 01.02.2026 to 15.02.2026. Thereafter, any uncleared cargo including detained, seized, confiscated or unclaimed cargo, shall be shifted by the CCSP to the aforesaid new facility under preventive escort within next 7 days under intimation to the concerned Section.

Any difficulties encountered in the implementation of this Public Notice may be brought to the notice of the Assistant Commissioner of Customs, CCSP Cell, JNCH (ccsp.jnch@gov.in) for timely resolution.
