Sub.:- Security of Cargo and Containers at CFS - Reg.

Please refer to HCCA Regulations, 2009, under which CFSs are appointed as the Customs Cargo Service provider. As per notification appointing CCSP, fulfilment of the conditions laid down in regulation 5 and discharge of your responsibilities as laid down in regulation 6 of HCCAR, 2009 are mandatory. These, inter-alia, includes responsibilities of ensuring safe, secure premises for storing of cargo, providing security and access control to prohibit unauthorized access into the premises.

- 2. In a follow up to a recent incident related to import container placed at a CFS, it was indicated inter-alia that RFID Tag affixed on the container was not functional, 25% CCTV Cameras installed were non-functional, 8 Cameras were not even connected to the CCTV System, No security measures were in place at the rear gate of the CFS.
- 3. The above is of added relevance because presently while effect on movement of container eases during the lock down period, the CFSs are individually holding larger inventory than before of import containers. Hence, exercise of diligence on the security aspect should be ensured.
