Terms and Conditions

- 1.The list is only tentative. The department reserves the right to increase or decrease the actual quantity required.
- 2.Unsigned bid application would not be considered.
- 3.The supplier should be registered with Service Tax Department and should submit a copy of Service Tax Registration Certificate.
- 4.The bidder should mention item-wise per-piece value of the items as well as the total price and the prices quoted shall be inclusive of all taxes of any government/ local authority etc. as applicable to government department. No payment over and above the prices quoted shall be done by the Customs in respect of any such levies brought to the notice at a later date.
- 5.The items supplied should have reasonable guarantee / warranty period. The bidder should mention the warranty/guarantee period for free servicing and replacement of parts of the product etc.
- 6.Bidder should have a good track record of supplying these items to Government Departments and should have past experience of dealing in these items.
- 7.All the items supplied should be of the brand and make as specified in the tender and supplier has to furnish Quality Assurance Certificate along with Invoice and goods.

8.The supplier will be responsible for installation, operation and maintenance for the Warranty period.

9.Delivery should be within 10 days of issue of Purchase Order.

10.The successful supplier has to submit a Bank Guarantee for 2 years (two years), issued from Nationalized Bank, within 7 days on acceptance of tender. The Bank Guarantee amount should be 5% of the accepted bid amount. The Commissioner of Customs reserves the right not to refund the Bank Guarantee amount in case the supplier fails to deliver the goods in time.

11.The Payment will be made only after receipts and successful installation, operation of the goods and furnishing of above mentioned Bank Guarantee.

12.The actual list of procurement of the goods will be given at the time of placing order.

13.Sealed tenders should be addressed to the Deputy Commissioner of Customs, EDI/(H/W) and reach within 21days from the date of issue of this notice. The last date of receiving the sealed tenders is 08.01.2015 till 05.00 P.M. Tenders received after the prescribed time limit will not be entertained. Sealed tenders that are incomplete and not addressed to proper authority shall be rejected.

14.The Commissioner of Customs reserves the right to reject / cancel any or all tenders received without assigning any reasons thereof.
