ESTT. OFFICE ORDER No. 25/2020

Whereas the Union Home Secretary, GOI, MHA Order No. 40-3/202-DM-1(A) dated 01.05.2020 has extended lockdown for a further period of two weeks with effect from 04.05.2020 for containment of spread of COVID-19 and also issued new guidelines, vide Order No.DMU/2020/CR.92/DisM-1 dated 02.05.2020, Chief Secretary, Government of Maharashtra has also issued directions for strict implementation of new revised guidelines.

- 2. Considering the above said Orders and the new Guidelines relating to functioning of Government offices and/or Customs, and keeping in view that this is to be read alongside the enforcement of National Directives for COVID 19 management, it has been decided, that at this stage, the officers/staff as specified in Annexure A, B, C, D and E with this Estt. Order shall present themselves in the workplace/office on the respective dates mentioned therein from the period 04.05.2020 to 17.05.2020. However, this roster may be revised considering all the relevant parameters including for unrestricted functioning of Customs. In addition, the officers / staff that are already working in Sections under respective shift roster system shall continue to follow those respective shift rosters.
- 3. The entire rest of the officers/staff (who are not attending the workplace/office on the dates other than mentioned against their name in Annexures A to E above) of the level up to Dy/Asst. Commissioner shall, at this initial stage, work from home during the period. For this, they are also required to be available on telephone and with electronic means of communication from the home. They shall also attend to/complete the tasks that are instructed to them for being attended from the home keeping in view the objective that when they return to workplace/office a substantive part of the work stands attended to and thereby any kind of backlogs are avoided. It should be clearly understood that such individuals are to comply the norms set by the Government/local Administrations during the period and that such expectations are taken as part and parcel of the Conduct Rules. These officers/staff members should note that they could be required to present themselves at the workplace/ office, as and when required.
- 4. The Additional/Joint Commissioner in charge of each Section/branches of work will closely monitor Customs functioning in office as well as the Docks/CFS and keep in consultation with the Commissioners. The monitoring includes that of tasks given to officers/staff who are being required to work from home. It should be kept in view and ensured that the Customs functioning remains unrestricted and for this any upcoming events and work trends should be

keenly observed so that the requirement of unrestricted Customs functioning is complied, including with suitable adjustments as are necessary. Where such adjustments require upward recaliberations of personnel, on the rosters, if the exigency arises for recalling a particular officer/staff to workplace/office on account of re-calibrating in light of such increases in operational requirement, the Addl./Jt. Commissioner would obtain the Order of the Commissioner to this effect. The Commissioner would be closely supervising for ensuring Customs functioning without restrictions.

- 5. Every person who is required to attend the workplace/work is to remain conscious of observing and ensuring her/his own preventive/safety measures and social distancing norms, as well as that of the other person, which include their to and fro, seating, standing, handling, restriction on number being together in vicinity or in queue or during breaks etc. These aspects are to be strictly and invariably complied as prescribed in Guidelines.
- 6. The officers whose names are listed in Annexure F with this Establishment Order shall also be responsible for ensuring enforcement of National Directives for COVID 19 management for public and work places including relevant social distancing, as part of their duties in the respective areas shown in Annexure F.
- 7. All officers and staff are directed to download the *Arogya Setu* app in their mobile phones and switch the functions on as required.
- 8. This is issued in consultation with and with the approval of Commissioner of Customs General/Export, NS-I/Audit, NS-III and NS-V, JNCH, Nhava-Sheva.
