ESTT. OFFICE ORDER No. 28/2020

This office had issued Estt. Office Order No.25/2020 dated 03.05.2020 prescribing roster for officers and staff of Mumbai Customs Zone-II till midnight of 17.05.2020. This was in addition to officers working on shift rosters.

2. The Govt of Maharashtra has issued Orders extending the lockdown in State of Maharashtra till midnight of 31.05.2020 for containment of Covid-19 epidemic along with directions to implement the Guidelines/Revised Consolidated Guidelines issued earlier. The Orders of the GOI, Ministry of Home Affairs are awaited.

3. Pending inter alia this, for the time being, the roster and other aspects in Estt Office Order No. 25/2020 dated 03.05.2020 are ordered to be repeated effective 18.05.2020 such that in the Annexures A to F thereof, as the case may be, the period 04.05.2020 to 10.05.2020 shall be read as 18.05.2020 to 24.05.2020 and the period 11.05.2020 to 17.05.2020 shall be read as 25.05.2020 to 31.05.2020. In addition, the officers/staff that are already working in sections under respective shift roster system shall continue to follow those respective shift rosters. Any other officer/staff who may otherwise be on work from home, if required to be present at the office workplace on account of exigency of work, shall also report for work at the office-work place.

4. This EOO shall be reviewed in a few days, keeping all relevant aspects in view. The EOO is issued in consultation with and with the approval of Commissioner of Customs General/Export, NS-I/Audit, NS-III and NS-V, Nhava Sheva. The Commissioner (Appeals) shall issue separate Order.
