Shri Tariq Mabood, Addl. Commissioner of Customs, NS-I Commissionerate, JNCH, started the discussion on the agenda points of the meeting relating to the import.

3) **BCBA के द्वारा उठाया गया कार्यबिन्दु/ Agenda Points raised by BCBA**

i. **कार्यबिन्दु संख्या 01/Agenda Point No.01:**

There are considerable numbers of Bond and BG pending which were given along with provisionally assessed BE under Carotar. These are pending for last 2-3 years. We suggest that status of verification of FTA under Carotar should be provided to Trade in order to check whether BE can be finally assessed if the verification is done.

प्रतिक्रिया/Response:-

Delays are occurring in the verification process due to third-country organizations having their own verification process. The concerned group is consistently following up with the Directorate of International Customs (DIC), CBIC, for verification of COOs and to resolve pending provisional assessments. It was suggested that three representatives from BCBA or other stakeholders may be assigned to each Commissionerate for direct interactions with Group officers to list out the pending cases for taking up the issue with DIC. BCBA and stakeholders are requested to assign individuals to liaise with officers in each Commissionerate, providing details of pending Bills of Entry and related matters.

ii. **कार्यबिन्दु संख्या 02/Agenda Point No.02:**

Suggestion towards improving AEM Functionality for wider reach and benefits

We enumerate below points and suggestion towards improvement in AEM Functionality.

(a) **Enabling AEM in all Bill of Entry Filed:**

Currently, AEM Module is enabled only in cases where there is 24 hour delay after Inward

- *AEM Module is yet to be enabled in cases of Advance Filing of BE and Ex-Bond BE.*
- *In case of BE Requiring Re-Assessment for any reason, the AEM Module is not enabled to Escalate delays in such cases.*

प्रतिक्रिया/Response:-

Ideally, the AEM module was aimed to ensure speedy clearance of goods which have already arrived at the Port. If the trade is of the view that the scope of AEM to be expanded including pending Bills of Entry filed in advance then members of PTFC are requested to submit additional suggestions in this regard for onward submission to DG System.

iii. कार्यबिन्दु संख्या 03/Agenda Point No. 03:

In cases of 100 % examination, order being received or erroneous sampling orders are issued at the time of OOC.

Request your kind intervention.

प्रतिक्रिया/Response:-

Trade was suggested to provide live references to the concerned Commissioner along with the details of bills of entry to identify whether the issue of giving 100% examination orders is related to particular FAG or it is happening in all FAGs across the country. After analysing the information, the issue may be considered to be forwarded for discussion with NAC members, to resolve the issue.

Any other Agenda Points :-


Examination under videography for containers which has given 100% examination orders:-
