CFS Notification 3/2025

Whereas an area admeasuring 8,24,678 sq. ft. of Container Freight Station Navkar located at Survey Nos. 89/93/95/97, Village Somathane, Kon-Savla Road, Taluka Panvel, District Raigad, Maharashtra-410206, was notified as a Customs Area under Section 8 of the Customs Act, 1962 vide Notification No. 6/2009 as amended and whereas M/s Navkar Corporation Limited was also appointed as a Custodian for a period of 10 years under Sections 45(1) and 141(2) of the Customs Act, 1962 vide Notification No. 05/2019 dated 31.05.2019, as amended.

And whereas, M/s. Navkar Corporation Limited has requested for de-notification of a part of the Customs Area admeasuring 3000 sq. mtrs. (equivalent to 32,292 sq. ft.), located on the western side of the CFS adjacent to the Central Railway Main Line.

Now, therefore, in exercise of the powers conferred upon me under Section 8(a) of the Customs Act, 1962, I, B. Sumidaa Devi, Commissioner of Customs (General), Jawaharlal Nehru Customs House, Nhava Sheva, hereby approve the denotification of an area of 32,292 sq ft from the approved area of 8,24,678 sq ft as shown in the enclosed layout plan of M/s Navkar Corporation Limited. An area admeasuring 7,92,386 sq. ft. remains notified as Customs Area for the purpose of unloading of imported goods and loading of export goods, and M/s Navkar Corporation Ltd. continues to be the custodian of imported cargo till their clearance for home consumption or transshipment and for export cargo brought into the CFS subject to strict compliance with the provisions of the Handling of Cargo in Customs Area Regulations, 2009, the Customs Act, 1962, and other instructions issued by the Government of India or the Commissioner of Customs, JNCH, from time to time.

Further, in exercise of the powers conferred under Section 8(b) of the

Customs Act, 1962, I hereby specify the limits of the Customs Area of M/s. Navkar Corporation Limited, CFS, as detailed in the Schedule below. The total area of the CFS, after the above de-notification, becomes 7,92,386 sq. ft. (73,615 sqm).

East Side: 15 mtrs. wide road and Kon-Savla Main Road

West Side: De-notified area encompassing the Central Railway Main Line & Navkar Domestic Railway Siding

South Side: 10 mtrs. wide road and Gat No. 87

North Side: Road of Gat No. 97/1A and open tunnel (Nala)
