Whereas 400 metres of quay & Approach Trestle of M/s. Bharat Mumbai Container Terminals located at J.N.Port, Village-Nhava-Sheva, Taluka-Uran, Distt. Raigad, Maharashtra was notified as the 'Customs Area' under the provisions of the Section 8 of the Customs Act, 1962 vide notification no. 04/2017 dated 25.05.2017. An additional quay area 200 metres located adjacent to the above quay was notified as the 'Customs Area' under the provisions of the Section 8 of the Customs Act, 1962 vide notification no. 12/2017 dated 29.09.2017.

And whereas total area admeasuring 4,86,836 sq. mtres. comprising of part of container yard, intake gate complex, Container road intake area and rail yard of M/s. Bharat Mumbai Container Terminals located at J.N.Port, Village-Nhava-Sheva, Taluka-Uran, Distt. Raigad, Maharashtra has been developed as mentioned in the Schedule below for their operations.

Therefore, in exercise of the powers conferred on me under Section 8(a) of the Customs Act, 1962, I, Utkaarsh R Tiwaari, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Nhava Sheva, hereby notify the said 4,86,836 sq. mtres. comprising of part of container yard, intake gate complex, Container road intake area and rail yard of M/s. Bharat Mumbai Container Terminals as a place for unloading of imported goods and for loading of export goods subject to the strict observance of the provisions of the Customs Act, 1962 and other instructions issued in this behalf by the Government of India or Commissioner of Customs (NS-General), Jawaharlal Nehru Customs House, from time to time.

Further, under Section 8(b) of the Customs Act, 1962, I, Utkaarsh R Tiwaari, Commissioner of Customs (General) hereby specify the limits of the Customs Area of the said 4,86,836 sq. mtres. comprising of part of container yard, intake gate complex, Container road intake area and rail yard of M/s. Bharat Mumbai Container Terminals under J.N.P.T, Nhava-Sheva, located at Village-Nhava-Sheva, Taluka-Uran, Distt. Raigad, Maharashtra. Total area admeasuring 4,86,836 Sq. Mtres. of land in the present project has Coordinates as follows-
