## **CORRIGENDUM**

Subject: Corrigendum to Order-in-Original No. 200/2025-26/COMMR/NS-V/CAC/JNCH dated 18.09.2025 issued by the Commissioner of Customs, NS-V, JNCH in the case of M/s. Datamini Technology (India) Limited (IEC- 2791000046) – reg.

Attention is invited to the Order-in-Original No. 200/2025-26/COMMR/NS-V/CAC/ JNCH dated 18.09.2025 issued by the Commissioner of Customs, NS-V, JNCH, in the case of M/s. Datamini Technology (India) Limited.

1. In para 5(i) at Page No. 30 of the Order-in-Original No. 200/2025-26/COMMR/NS-V/CAC/JNCH dated 18.09.2025, the words:

"I order that the differential / short paid duty amounting to Rs. 56,65,418/- (81,98,893 – 25,33,475) (Rupees Fifty Six Lakh Sixty Five Thousand Four Hundred Eighteen Only) for the subject goods imported vide 7 Bills of Entry (i.e. except B/E No. 5344461 dtd. 18.10.2019, 5456320 dtd. 26.10.2019 & 9984741 dtd. 16.12.2020) as detailed in Annexure-'A' to the subject SCN, should be demanded from M/s. Datamini Technology (India) Limited under Section 28(4) of the Custom Act, 1962."

#### May be read as

"I confirm the demand of differential / short paid duty amounting to Rs. 56,65,418/-(81,98,893 – 25,33,475) (Rupees Fifty Six Lakh Sixty Five Thousand Four Hundred Eighteen Only) for the subject goods imported vide 7 Bills of Entry (i.e. except B/E No. 5344461 dtd. 18.10.2019, 5456320 dtd. 26.10.2019 & 9984741 dtd. 16.12.2020) as detailed in Annexure-'A' to the subject SCN, and order to recover the same from M/s. Datamini Technology (India) Limited under Section 28(4) of the Custom Act, 1962."

2. In para 5(ii) at Page No. 30 of the Order-in-Original No. 200/2025-26/COMMR/NS-V/CAC/JNCH dated 18.09.2025, the words:

"I order that in addition to the duty short paid, interest on delayed payment of Custom duty should be recovered from M/s. Datamini Technology (India) Limited under Section 28AA of the Customs Act, 1962."

## May be read as

"I order to recover interest on delayed payment of Custom duty from M/s. Datamini Technology (India) Limited under Section 28AA of the Customs Act, 1962."

3. In para 5(iii) at Page No. 30 of the Order-in-Original No. 200/2025-26/COMMR/NS-

## V/CAC/JNCH dated 18.09.2025, the words:

"I hold the said subject goods imported vide 7 Bills of Entry (i.e. except B/E No. 5344461 dtd. 18.10.2019, 5456320 dtd. 26.10.2019 & 9984741 dtd. 16.12.2020) as detailed in Annexure-'A' to the subject SCN, having assessable value of Rs. 4,36,47,288/-(5,66,59,490 – 1,30,12,202) (Rupees Four Crore Thirty Six Lakh Forty Seven Thousand Two Hundred Eighty Eight Only) liable for confiscation under Section 111(o) of the Customs Act, 1962.

However, since the goods are not available, I impose a redemption fine of Rs. 40,00,000/- (Rupees Forty Lakh Only) on M/s. Datamini Technology (India) Limited in lieu of confiscation under Section 125(1) of the Customs Act, 1962."

## May be read as

"I order to confiscate the said subject goods imported vide 7 Bills of Entry (i.e. except B/E No. 5344461 dtd. 18.10.2019, 5456320 dtd. 26.10.2019 & 9984741 dtd. 16.12.2020) as detailed in Annexure-'A' to the subject SCN, having assessable value of Rs. 4,36,47,288/- (5,66,59,490 – 1,30,12,202) (Rupees Four Crore Thirty Six Lakh Forty Seven Thousand Two Hundred Eighty Eight Only), under Section 111(o) of the Customs Act, 1962.

I also impose a redemption fine of **Rs. 40,00,000/- (Rupees Forty Lakh Only)** on M/s. Datamini Technology (India) Limited in lieu of confiscation under Section 125(1) of the Customs Act, 1962."

4. Rest of the contents of the aforesaid Order-in-Original remains unchanged.
