CORRIGENDUM

Subject: Corrigendum to Order-in-Original No. 204/2025-26/COMMR/NS-V/CAC/JNCH dated 22,09,2025 issued by the Commissioner of Customs, NS-V, JNCH in the case of M/s Rays Power Infra Private Limited (IEC -1312016132) - reg.

Attention is invited to the Order-in-Original No. 204/2025-26/COMMR/NS-V/CAC/ INCH dated 22.09.2025 issued by the Commissioner of Customs, NS-V, JNCH, in the case of M/s Rays Power Infra Private Limited.

1. In para 5(a) at Page No. 22 of the Order-in-Original No. 204/2025-26/COMMR/NS-V/CAC/JNCH dated 22.09.2025, the words:

"I order that the differential / short paid duty amounting to Rs. 1,63,55,755/- (Rupees One Crore Sixty Three Lakh Fifty Five Thousand Seven Hundred Fifty Five Only) for the subject goods imported vide Bills of Entry as detailed in Annexure-'A' to the subject SCN, should be demanded from the importer, M/s Rays Power Infra Private Limited under Section 28(4) of the Custom Act, 1962."

May be read as

"I confirm the demand of differential / short paid duty amounting to Rs. 1,63,55,755/-(Rupees One Crore Sixty Three Lakh Fifty Five Thousand Seven Hundred Fifty Five Only) for the subject goods imported vide Bills of Entry as detailed in Annexure-'A' to the subject SCN, and order to recover the same from M/s Rays Power Infra Private Limited under Section 28(4) of the Custom Act, 1962."

2. In para 5(b) at Page No. 22 of the Order-in-Original No. 204/2025-26/COMMR/NS-V/CAC/JNCH dated 22.09.2025, the words:

"I order that in addition to the duty short paid, interest on delayed payment of Custom duty should be recovered from the importer, M/s Rays Power Infra Private Limited under Section 28AA of the Customs Act, 1962."

May be read as

"I order to recover interest on delayed payment of Custom duty from M/s Rays Power Infra Private Limited under Section 28AA of the Customs Act, 1962."

3. In para 5(c) at Page No. 22 of the Order-in-Original No. 204/2025-26/COMMR/NS-V/CAC/JNCH dated 22.09.2025, the words:

Page 1 of 2

"I order than the said values goods imported vide Bills of Entry as detailed in Annexure-A" to the subject SCN having accessable value of Rs. 11.90.44.773. (Rupues Eleven Crore Ninety Lakh Forty From Thomsand Seven Handred Seventy Five Only) should be held liable for confiscation under Section 111(m) and 111(n) of the Custom Act. 1962.

Homesser: since the goods are not available. I impose a redomption fine of **Rs.** 1.20,00,000; (Rupees One Crore Twenty Lakh Only) on Ms Rays Power Infra Private Limited in lien of confiscation under Section 125(1) of the Customs Act, 1962."

May be read as

"I order to confiscate the said subject goods imported vide Bills of Entry as detailed in Annexanc-A" to the subject SCN having assessable value of Rs. 11.90,44,775/- (Rupees Eleven Crore Ninety Lakh Forty Four Thousand Seven Hundred Seventy Five Only), under Section 111(m) and 111(o) of the Custom Act, 1962.

I also impose a redemption fine of Rs. 1,20,00,000/- (Rupees One Crore Twenty Lakh Only) on M's Rays Power Infra Private Limited in lieu of confiscation under Section 125(1) of the Customs Act, 1962."

Rest of the contents of the aforesaid Order-in-Original remains unchanged.
