Subject: Corrigendum to Order-in-Original No. 211/2025-26/COMMR/NS-V/CAC/JNCH dated 29.09.2025 issued by the Commissioner of Customs, NS-V, JNCH in the case of M/s IKEA India Private Limited (IEC: 0514055472) – reg.

Attention is invited to the Order-in-Original No. 211/2025-26/COMMR/NS-V/CAC/ JNCH dated 29.09.2025 issued by the Commissioner of Customs, NS-V, JNCH, in the case of M/s IKEA India Private Limited.

1. In para 5(i) at Page No. 62 of the Order-in-Original No. 211/2025-26/COMMR/NS-V/CAC/JNCH dated 29.09.2025, the words:

"I order that the total differential duty amounting to Rs. 1,14,36,657/- (Rupees One Crore Fourteen Lakh Thirty Six Thousand Six Hundred Fifty Seven Only) for the period from 10th October, 2019 to 31st August, 2024 should be demanded and recovered from M/s IKEA India Private Limited under the provisions of Section 28(4) of the Customs Act, 1962, along with interest under Section 28AA ibid."

May be read as

"I confirm the total differential duty amounting to Rs. 1,14,36,657/- (Rupees One Crore Fourteen Lakh Thirty Six Thousand Six Hundred Fifty Seven Only) for the period from 10th October, 2019 to 31st August, 2024, and order to recover the same from M/s IKEA India Private Limited, under the provisions of Section 28(4) of the Customs Act, 1962, along with interest under Section 28AA ibid."

2. In para 5(ii) at Page No. 62 of the Order-in-Original No. 211/2025-26/COMMR/NS-V/CAC/JNCH dated 29.09.2025, the words:

"I hold the goods (KOMPLEMENT BOXES and KOMPLEMENT MESH BASKET) imported during the period from 10th October, 2019 to 31st August, 2024 valued at Rs. 5,87,39,890/- (Rupees Five Crore Eighty Seven Lakh Thirty Nine Thousand Eight Hundred Ninety Only) liable to confiscation under Section 111(m) of the Customs Act, 1962.

However, since the goods are not available, I impose a redemption fine of Rs. 30,00,000/- (Rupees Thirty Lakh Only) on M/s IKEA India Private Limited, in lieu of confiscation under Section 125(1) of the Customs Act, 1962."
