CORRIGENDUM TO

ORDER-IN-ORIGINAL NO.- 1230/2025-26/ADC/CEAC/NS-II/CAC/JNCH Dated 28.11.2025 PERTAINING TO M/s. Doswani Multiventures (IEC-AAVFD9670Q).

In exercise of the power u/s 154 of the Custom Act, 1962, in the order portion at **Para 36 (xii)** of the ORDER-IN-ORIGINAL NO.- 1230/2025-26/ADC/CEAC/NS-II/CAC/JNCH instead of -

“I order to confiscate goods covered under the past 05 Shipping Bills, as mentioned in ‘Table-V’ above, having total declared FOB of Rs. 2,77,07,465/- (Rupees Two Crore Seventy Seven Lakh Seven Thousand Four Hundred Sixty Five only), under Section 113(ia) and 113(ja) of the Customs Act, 1962. I impose Redemption Fine of Rs. 500,000/- (Rupees Fifty Thousand only) on the Exporter, M/s. Doswani Multiventures (IEC AAVFD9670Q), under the provisions of Section 125 of the Customs Act, 1962 in lieu of confiscation of the goods.”

The following shall be substituted-

“I order to confiscate goods covered under the past 05 Shipping Bills, as mentioned in ‘Table-V’ above, having total declared FOB of Rs. 2,77,07,465/- (Rupees Two Crore Seventy Seven Lakh Seven Thousand Four Hundred Sixty Five only), under Section 113(ia) and 113(ja) of the Customs Act, 1962. I impose Redemption Fine of Rs. 5,00,000/- (Rupees Five Lakh only) on the Exporter, M/s. Doswani Multiventures (IEC AAVFD9670Q), under the provisions of Section 125 of the Customs Act, 1962 in lieu of confiscation of the goods.”
