CORRIGENDUM

Subject:- Corrigendum to the Order-in-Original No. PCCP/ADJ/AH/09/2025-26 dated 18.11.2025 issued under F.No. S/10-197/23-24/Commr/NS-V/CAC/JNCH in the case of Arigato & Obligado Merchandise Pvt. Ltd. – reg.

In the subject Order-in-Original No. PCCP/ADJ/AH/09/2025-26 dated 18.11.2025, Para No.27(iv) of the Order part (at Page No. 28) mentioned as -

(iv) "I impose penalty of Rs.2,48,777/- (Rupees Two Lakh Forty-eight Thousand Seven Hundred Seventy-seven only) on the noticee viz., M/s. Arigato & Obligado Merchandise Pvt. Ltd. under Section 114A of the Customs Act, 1962. However, in terms of first and second proviso to Section 114A ibid, if the duty and the interest payable thereon is paid within thirty days from the date of the communication of this order, the amount of penalty liable to be paid by the noticee shall be twenty-five percent of the duty, subject to the condition that the amount of penalty so determined has also been paid within the period of thirty days."

shall be read as –

(iv) "I impose penalty equal to the duty amount of Rs.2,48,777/- plus interest thereon, as confirmed at (i) and (ii) above, on the noticee viz., M/s. Arigato & Obligado Merchandise Pvt. Ltd. under Section 114A of the Customs Act, 1962. However, in terms of first and second proviso to Section 114A ibid, if the duty and the interest payable thereon is paid within thirty days from the date of the communication of this order, the amount of penalty liable to be paid by the noticee shall be twenty-five percent of the duty, subject to the condition that the amount of penalty so determined has also been paid within the period of thirty days."
