PUBLIC NOTICE NO.84/2010

Sub: Import of goods under [Notification No. 13/2010-Customs](#) dated 19.02.2010 for Commonwealth Games, 2010- Regarding.

Attention is invited to all Importers/CHAs, that Government of India has issued [Notification No. 13/2010-Customs](#) dated 19.02.2010 granting exemption from customs duty on specified goods imported into India for the purpose of organizing the Commonwealth Games to be held in October, 2010 in New Delhi. Accordingly Central Board of Excise and Customs (CBEC) has issued [Circular No. 28/2010-Customs](#) dated 13.08.2010.

2 In addition to this, JNCH has designated Shri P. Anjani Kumar, Addl. Commissioner of Customs as Nodal Officer for co-ordination between Organizing Committee, Commonwealth Games-2010 and JNCH Customs.

3. In order to ensure expeditious clearances of all consignments already imported and pending clearances in the CFSs, it has been instructed that as soon as the representative of Organizing Committee, CWG or Prasar Bharti applies to Customs for NOC/permission to amend the import documents viz. IGM and Bill of Lading to include itself as the importer, in place of contractors/vendors/sub-vendors with accompanying NOC from the Importer on record, DC/AC of concerned group shall promptly give NOC. Thereafter, DC/AC Import Noting will ensure that the amendment request is accepted expeditiously to enable the OC/CWG to amend the name of importer in concerned bill of entry.

4. Where the bill of entry has not been filed, the representative of OC CWG or Prasar Bharti will file the same in its own name after amendment in IGM and Bill of Lading.

5. JNCH has also made arrangements for holiday postings to facilitate import. The person handling the consignments imported into India for the purpose of organizing the Commonwealth Games may approach the concerned Dy/Asstt. Commissioner and Appraising Officer posted for holiday postings.

6. Since Commonwealth Games is an event of national importance, the Dy./Asstt. Commissioners I/c. of Groups and Import Docks will ensure that there is no delay in assessment and clearance of these goods subject to fulfillment of the conditions of [Notification No. 13/2010-Customs](#) dated 19.02.2010.

7. Any difficulty faced in implementation of this Public Notice may be brought to the notice of the undersigned.
