**Public Notice No.44/2022**


The area admeasuring 41990.89 SQM of Container Freight Station located at Plot No. 70-81, Sector 1, Dronagiri Node, Taluka Uran, Distt. Raigad, Maharashtra was declared as Customs Area under section 8 of the Customs Act, 1962 vide Notification No. 05/2004 dated 16.09.2004 and Notification No. 01/2007 dated 17.12.2007. Further M/s Seabird Marine Services Pvt. Ltd. was appointed as "Custodian" and "Customs Cargo Service Provider" vide Notification No. 05/2010 dated 15.03.2010 and vide Notification No. 06/2015 dated 27.02.2015 for the area for duration of 05 years which was further extended vide Public Notice No. 75/2020 dated 24.06.2020 for a period of 05 years from 15.03.2020.

5. Now, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act, 1962, I, Istikhar Baig, Commissioner of Customs, General, Mumbai Zone- II, Nhava Sheva hereby appoint M/s Seabird Marine Services Pvt. Ltd to be the 'Custodian' of the Imported goods received at the Container Freight Station of M/s Seabird Marine Services Pvt. Ltd until these are cleared for home consumption or are warehoused or are transhipped in accordance with the provisions of Chapter VIII of the Customs Act, 1962 for the entire Customs Area of 41990.89 SQM. Similarly, M/s Seabird Marine Services Pvt. Ltd will also be the 'Custodian' of the Export cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port.

6. Further, in exercise of the powers conferred on me under Regulation 10 of the "Handling of Cargo in Customs Areas Regulations, 2009", I, Istikhar Baig, Commissioner of Customs, General, JNCH hereby approve M/s Seabird Marine Services Pvt. Ltd as a "Customs Cargo Services Provider" for the above mentioned Container Freight Station subject to the following conditions;

- (i) The Custodian M/s Seabird Marine Services Pvt. Ltd approved as "Customs Cargo Services Provider" for the said CFS shall abide by all the provisions of the Customs Act, 1962 and the rules under the "Handling of

- Cargo in Customs Areas Regulations, 2019" and other regulations, notifications, orders issued there under.
- (ii) The duration of appointment of M/s Seabird Marine Services Pvt. Ltd as 'Custodian' and as the 'Customs Cargo Service Provider' shall remain valid for a **period of Ten (10) year from 15.03.2020** provided the validity of the AEO-LO status of the CFS extended. If the validity of AEO status granted to the CFS is withdrawn prior to the 14.01.2023 or is not extended beyond 14.01.2023 the validity shall be valid for a **period of five (05) year from 15.03.2020 instead of ten (10) year.**
- (iii) The waiver from execution of Bank Guarantee has been given in terms of regulation 5(3) of HCCAR, 2009 as the CFS has been accredited with AEO-LO status with validity till 14.01.2023. If the validity of AEO status granted to the CFS is withdrawn prior to the 14.01.2023 or is not extended beyond 14.01.2023, the CFS shall execute bank guarantee for the amount, as determined, w.e.f. date of expiry of validity of AEO status.
- (iv) The Commissioner of Customs (General), JNCH shall have the Right to review the approval as 'Customs Cargo Services Provider' before the completion of ten year for failure to comply with any of the Regulations of the "Handling of Cargo in Customs Areas Regulations, 2009 or as per the directions of the Government of India.
