2. *M/s. Xeam Ventures Pvt. Ltd.* Has been awarded a contract to operate at the EDI Site Jawaharlal Nehru Customs House with effect from 05.09.2022. While the Vendor for providing Services has remained unchanged, the important changes in the new Service Centre Agreement are as below:

- b. The vendor will issue a tax invoice with a GST Number for the services it has rendered. The receipt for payment must be digitally generated.
- c. Period of the contract is fixed as 2 years with effect from 05.09.2022.


