Whereas the area admeasuring **54336 SQM** of Container Freight Station M/s EFC Logistics India Pvt. Ltd., located at village: Veshvi, Post: Dighore Tal: Uran. Distt: Raigad, Maharashtra 410 207 was notified as Customs Area under the provision of the section 8 of the Customs Act, 1962 vide CFS Notification No. 08/2015 dated 12.03.2015. M/s EFC Logistics India Pvt. Ltd., notifying an area of 36830 SQM, Notification No. 23/2015 dated 09.06.2015 notifying an additional area of 1956 SQM, Notification No. 10/2016 dated 28.10.2016 notifying an additional area of 8460 SQM, Public Notice No. 07/2022 dated 27.01.2022 notifying an additional area of 7090 SQM. In all the total area of **54336 SQM** had been declared as Customs Area for the said CFS M/s EFC Logistics India Pvt. Ltd. Now CFS M/s EFC Logistics India Pvt. Ltd., has acquired and developed additional land admeasuring **15263.43 SQM** mentioned in the schedule below for their CFS.

Garbyal, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone II, Nhava Sheva, Navi Mumbai, Maharashtra hereby notify the additional land admeasuring 15263.43 SQM as mentioned in the schedule below of M/s EFC Logistics India Pvt. Ltd., as a place for unloading of imported goods and for loading of export goods subject to the strict observance of the provisions of the Customs Act, 1962 and other instructions issued in this behalf by the Government of India or the Commissioner of Customs, Nhava Sheva (General), Mumbai Customs, Zone II, Jawaharlal Nehru Custom House from time to time.
- 3. Further, in exercise of the powers conferred by Section 8(b) of the Customs Act, 1962, I, D. S. Garbyal, the Commissioner of Customs, Nhava Sheva (General), Mumbai Customs, Zone II, Jawaharlal Nehru Custom House, hereby specify the limits of the Customs Area, added to the CFS as the area of land parcels within the survey numbers of the land as mentioned in the schedule below.
