PUBLIC NOTICE No. 78/2024

Subject: Implementation of automation in the Customs (Import of Goods at Concessional Rate of Duty or for Specified End Use) Rules, 2022 in respect of EOUs with effect from 25.09.2024 - reg.

Reference is drawn to the CBIC Circular no. 11/2024-Customs dated 25.08.2024 and JNCH Public Notice no. 75/2024 dated 28.08.2024 regarding Implementation of automation in the Customs (Import of Goods at Concessional Rate of Duty or for Specified End Use) Rules, 2022 in respect of EOUs with effect from 01.09.2024.

- 2. Representations have been received from several EOUs and Export Promotion Council for EOUs and SEZs regarding problems faced by EOUs in registration, generation of IIN details and utilising continuity bonds which may lead to delay in the clearance of the goods.
- 3. Considering the request of stakeholders, Board has decided to implement the above Circular No. 11/2024 - Customs dated 25.08.2024 in relation to EOUs with effect from 25.09.2024.
  - 4. This Public Notice should be considered as Standing Order for the concerned Officers and staff of this Customs House. All the concerned officers are directed that the trade is proactively assisted during the transition period keeping in view the resolved to provide an enabling environment for manufacturing.
- 5. In case of any difficulty, the same may be brought to the notice of Additional Commissioner in charge of Appraising Main (Import), NS-I (email address: appraisingmain.jnch@gov.in)
- 6. All the stakeholders including the trade and concerned associations are requested to take note of above for necessary action.
