Subject: Launch of Online Module on ICEGATE 2.0 for Permissions under Section 65 (MOOWR & MOOSWR) – regarding.

- 1. It is hereby informed to all importers, exporters, warehouse licensees, Customs Brokers, and other stakeholders that the Central Board of Indirect Taxes & Customs (CBIC) has operationalised a dedicated online module on ICEGATE 2.0 to streamline and simplify the submission of applications for permissions under Section 65 of the Customs Act, 1962, covering the following categories:
- a. MOOWR Manufacture and Other Operations in Warehouse Regulations, 2019
   as applicable to warehouses licensed under section 58;
- b. MOOSWR Manufacture and Other Operations in Special Warehouse Regulations, 2020 applicable to special warehouses licensed under Section 58A.
