## PUBLIC NOTICE NO.30/2025

M/s Central warehousing Corporation, (i.e. CWC) located at D\* Node. Taluka Uran. sit. Raigad. Maharashtra was earlier declared as Custodian of Container Freight Station under section 45 of the Customs Act, 1962 vide notification no. 24/2006 dated 01.08.2006 and the approval has been renewed from time to time vide various notifications issued in this regard. Vide Notification No. 20/2015 dated 17.04.2015, the renewal of approval as CCSP and Custodian has been extended for further 5 years was valid till 15.03.2020 and vide notification no 84/2020 dated 20.07.2020 for further five years till 14.03.2025..

- 2) Now, in exercise of the powers conferred on me under Section 45(1) and 141 (2) of the Customs Act. 1962. I. D, S. Garbyal. Commissioner of Customs. NS-General. JNCH. hereby renew the appointment of M/s. Central warehousing Corporation. D' Node as Custodian of the imported goods received at the Container Freight Station M/s. Central warehousing Corporation. D' Node until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provision of Chapter VIII of the Customs Act. 1962. Similarly, M/s. Central warehousing Corporation. D' Node will also be the Custodian of the Export Cargo brought into said Container Freight Station. for examination and stuffing till their exportation through Jawaharlal Nehru Port.
- 3). Further, in exercise of the powers conferred on me under Regulation 10 of the Handling of Cargo in Customs Area Regulations 2009. I, D. S. Garbyal, Commissioner of Customs, NS-General, JNCH, hereby renew the approval of M/s. Central warehousing Corporation, D' Node as 'Customs Cargo Services Provider' and Custodian for the said CFS Ms. Central warehousing Corporation, D' Node subject to the following conditions:
- (i). M/s. Central warehousing Corporation, D'Node approved as Customs Cargo Service Provider' and Custodian' for the said &S shall abide by all the provisions of the Customs Act 1962, the rules of the Handling of Cargo in Customs Areas Regulations, 2009and others regulations, notifications, orders issued there-under.
- (ii). The duration of appointment of M/s. Central warehousing Corporation, D' Node as 'Custodian and as Customs Cargo Services Provider' shall remain valid for five (5) years from 15.03.2025.
- (ii). The Commissioner of Customs, NS-General, JNCH, shall have right to review the approval as 'Customs Cargo Services Provider' and'Custodian' before completion of five years for their failure to comply with any of Regulations of the 'Handling of Cargo in Customs Areas Regulations, 2009' by CWC D'Node or as per the directions of the Government of India.
