PUBLIC NOTICE NO.37/2025**Sub: Cancellation of LUT BOND/BG in respect of DEEC Licenses -reg.**

Attention of all the concerned Advance License holders is invited to Public Notice No 11/2011, dated 10.02.2011. JNCH, Nhava Sheva has received a list of 18,500 Advance Authorisations from the office of ADGFT Mumbai vide mail dated 24.03.2025, wherein they have mentioned that these authorisations have been closed by them. Out of these 18,500 Advance Authorisations, Nine Hundred Twenty Five(925), cases selected for detailed verification are annexed herewith as '**Annexure A**'.

2. The Authorisation Holders mentioned in Annexure A are requested to furnish the required documents as per Annexure 'A' contained in P.N.11/2011 dated 10.02.2011, to the DEEC Monitoring Cell, 7th Floor, JNCH, Nhava-Sheva, on or before 31.03.2025, for verification of exports and consequent cancellation of BG/LUT.

3. List of cases(17575) where verification is not required is annexed as '**Annexure B**'. Since the EODCs in these cases have not been received, the importer shall submit the EODC on X-MAS portal available on JNCH website.

4. Submission of Documents

The above-mentioned licence holders, as detailed in Table in Para 1, are requested to submit the following documents by email to **jnch-dmc@gov.in** through their entity-based email ID so that verification can be completed while exporters may submit the original documents in due course.

List of documents for detailed verification:

- I. EODC/Redemption Letter
- II. ANF 4F duly certified by Chartered Accountant
- III. DEEC License along with duty debit speech
- IV. Copy of S/Bs (ARE-1 in case deemed exports)
- V. Bank Realization Certificate
- VI. In case third party export (documents as per FTP 2015-20)
- VII. Other relevant documents submitted to DGFT.

5. The Bond and Bank Guarantee will be released after the submission of original documents, as detailed above.
6. It is hereby informed that the bond submitted against the above said advance authorization in TSK/JNCH shall be forwarded to EPSMMC, JNCH for placing in concerned file for closure/disposal of advance authorization.
7. Authorisation Holders can also view the status of all thier licenses and update the status thereon by submitting the requisite documents on X-MAS portal (link <https://epsmmc-licenses.jnch.in/SearchDetails>.) available on JNCH website.
