CORRIGENDUM CUM ADDENDUM

Subject: Corrigendum cum Addendum U/S 154 of the Customs Act, 1962, to the Show Cause Notice No. 05/2022-23/DBK/BRC dated 29.06.2022 in the matter of M/s. Ozzy Exports (IEC: MJFPS9195E).

Reference is drawn to the Show Cause Notice No. 05/2022-23/DBK/BRC dated 29.06.2022 in the matter of M/s. Ozzy Exports. This Corrigendum cum Addendum is being issued under Section 154 of the Customs Act, 1962. Accordingly following corrections/additions are being incorporated in Para 2 and Para 20 of the said SCN:

I. Para 2 of the captioned SCN last line may be read as:

“FOB value of is Rs.3,14,21,250/- and Rs. 986.39 lakhs respectively, and under Export Promotion Scheme, for claimed drawback benefit of Rs.7,31,000/- and 27.71 lakhs”

instead of

“FOB value of is Rs.3,14,21,250/- and Rs. 986.39 Cr. respectively, and under Export Promotion Scheme, for claimed drawback benefit of Rs.7,31,000/- and 27.71 Cr”.

II. In Para 20 of the captioned SCN following sub para may be added:

“(vii) The said impugned export goods covered under the 14 Shipping Bills as listed in Table - 1 and Table - 2 mentioned above having total declared FOB value of Rs. 13,00,60,250/- which appears to be mis-declared in terms of value, should not be confiscated under the Provisions of Section 113(i), 113(ia) and 113(ja) of the Customs Act, 1962.”

III. All other contents of the Show Cause Notice remain unchanged.
