**STANDING ORDER 47/04**

**Sub : Examination of Cargo imported for subsequent re-export reg.**

Complaints have been received from trade that goods imported for the purpose of immediate re-export, without being stored in Customs Bonded Ware house, are being subjected to examinations by the officers on the import side and then by officers on the export side. This creates difficulties for the trade and also leads to delay. To surmount this, following procedure is to be adopted in this regard.

Whenever any party imports goods for the purpose of re-export, it must be informed by importer/CHA whether the goods are to be re-exported immediately or whether they would be stored in Customs bonded ware house prior to re-export. In those cases where goods are to be re-exported immediately without these being moved into and stored in the Customs bonded warehouse, the goods will be examined by the Appraising Officer (Imports Docks) and Supdt. of Customs (Docks examination exports) jointly. After examination, the goods will be stuffed into the Export Container under supervision of proper Customs Officer and the container will be sealed. In such cases there shall not be any separate/further examination by officers of Imports and Exports department posted in Docks.
