Kind attention is invited to the reference regarding, Export of Milk/Milk Products (Quality Control, Inspection and Monitoring) Rules, 2000, notified vide S.O.4032(E) dated (9/11-2020, wherein it has been mandated that facilities intended for production of milk & milk products for the purpose of international trade are to be accredited by recognised Export Inspection Agencies, established under section 7 of the THE EXPORT (QUALITY CONTROL AND INSPECTION) ACT, 1963. Further, the said notification, it has been mandated that each export consignment of milk & milk products should invariably accompany an Export Inspection Certificate to the effect that the facility producing such products is approved and monitored by the Export Inspection Agency established under provisions of THE EXPORT (QUALITY CONTROL AND INSPECTION) ACT, 1963

Further, JNCH public Notice No.149/2017 dated 16.11.2017 also mandated on Export of Milk/Milk Products (Quality Control, Inspection and Monitoring) Rules-2000, wherein Customs Officer shall ensure before export is affected every consignments of Milk/Milk Products should produce Certificate/NOC issued by Export Inspection Agency. The validity of such Export Certificate/NOC shall be 45 days from the date of issuance.

In view of the above submission Exporter are sensitized/directed to produce EIA Certificate before export of Milk/Milk Products every consignments product should adhere with Certificate/NOC issued by Export Inspection Agency as per Milk Products (Quality Control. Inspection ant Monitoring) Rules, 2000, notified vide s.o.4032(E) dated 09.11.2020.
