Standing Order No. 27 of 2023

Subject: Placement Committee for transfer/rotation in the grade of Superintendent of Customs (P) and Inspectors (Preventive Officer) -reg.

- 1. In terms of Para o6 of the Standing Order No. 13/2019 dated 02.07.2019, the Principal Commissioner of Customs, NS-I is nominated as a member of the Placement Committee for transfer and postings of officers in the grade of Superintendent of Customs (Prev.). Accordingly, the Placement Committee for transfer and postings of officers in the grade of Superintendent of Customs (Prev.) shall consist of the Pr. Commissioner of Customs, NS-I, the Commissioner of Customs (General), the Commissioner of Customs, NS-II (Exports) and the Commissioner of Customs, NS-IV (Audit). Further the Pr. Commissioner of Customs, NS-I being the senior most, would be the Chairman of the said Committee.
- 2. Further, in terms of Para o6 of the Standing Order No. 13/2019 dated 02.07.2019, the Placement Committee for transfer and postings of officers in the grade of Inspectors (Preventive Officer) shall consist of the Addl./Jt. Commissioner, CCO, Addl./Jt. Commissioner (Prev.-Gen.) and Addl./Jt. Commissioner (Vigilance). The senior most Officer would be the Chairman of the said Committee.
- **2.1** The Standing Order No. 13/2019 dated 02.07.2019 has prescribed that the recommendations of Placement Committee for transfer and postings of officers in the grade of Inspectors (Preventive Officer) shall be put up before the Competent Authority for approval. It has been decided that **the Commissioner of Customs (General)** shall be the said Competent Authority.
- **3.** While making its recommendations for transfer and posting of officers, the above Placement Committees shall inter-alia take into account the updated and prescribed Policies, general principles, objectives, guidelines, procedures or instructions.
- 4. The Standing Order No.21 of 2021 dated 30.07.2021 issued by this Office and the Office Note dated 27.07.2021 issued vide F.No.S/5-Gen-11/2020-21/P&E/JNCH by the Office of the Commissioner of Customs (General) on this subject, stand withdrawn with immediate effect.
- 5. This issues with the approval of the Chief Commissioner of Customs, JNCH, Mumbai Customs Zone-II.
