Sealed quotations are invited from reputed Pest Control Service Provider for the “Annual Pest Control Service Contract” for the Pest Control covering area under the Jawaharlal Nehru Customs House, Nhava-Sheva, Tal-Uran, Dist. – Raigad, Maharashtra for a period of one year from the date of entering into the contract.

This Custom House building is a ground+seven (07) storey building, having three wings at each floor which covers all the areas in Jawaharlal Nehru Customs Building including the rooms, corridors, passages, canteen, staircases, drainage, toilets, lift well etc. and the treatment will be for all types of insects including termites, white ants, rodents, cockroaches, spiders, mosquitoes, flies, lizards, ants, rats and mice etc.

The contract will be comprehensive in nature as per details below:-

1. Anti Termites (White Ants) Treatment:

This initial major comprehensive treatment should be followed up by check up treatment at quarterly intervals.

2. Anti Pest Treatment :

Treatment for the entire building should be carried out by spraying suitable insecticide in the entire building to keep the premises free from crawling insects. One major treatment every two months (bi-monthly service) and supplementary service on receipt of any complaint.

3. Rodent Control Treatment:

Rodent control should include installing bait stations around the building & proper monitoring of rat population by carrying out Rodent Management Programme by baiting method. This should be done on monthly basis.

The quotations should comprise the charges separately for anti termite, anti pest & rodent control treatments. The total contract amount will be paid only on satisfactory completion of work in four equal quarterly installments payable after completion of each major quarterly service. The AMC shall include cost of all types of materials used and all prevalent taxes including Sales Tax or any other tax applicable on materials or finished work like Service Tax, Works Contract Tax etc.

The successful bidder will be appointed on experimental basis for the first three months for evaluation of their performance, if not found satisfactory, their appointment will be summarily terminated.

Sealed tenders alongwith a Demand Draft for the amount equal to 2% of the total tender amount drawn in favour of Commissioner of Customs (Export), JNCH, Nhava Sheva, towards Earnest Money Deposit (EMD) should reach the undersigned alongwith the quotation within twenty one days from the date of publication of this notice i.e. on 05.11.2013. Sealed tenders will be opened at 1500 hrs on 08.11.2013.

Reputed pest control service providers may approach Supdt. of Customs, CHS section, JNCH for verifying the actual area on any working day during 11 am to 5 pm. The tender forms can be downloaded from this Custom House website <http://www.jawaharcustoms.in>. Tenders received after the prescribed time limit will not be entertained. The sealed envelope containing the quotation is to be superscribed 'QUOTATION FOR PEST CONTROL AT JNCH'. The Commissioner of Customs (Export), JawaharLal Nehru Customs House, reserves the right to reject any or all the quotations without assigning any reasons thereof.

The sealed tenders will be received by the undersigned till 1500 hrs on 05.11.2013 and will be opened on 08.11.2013 at 1500 hrs in the presence of vendors at JNCH.

The acceptance of the tender will rest with the Commissioner of Customs (Export) who does not bind himself to accept the lowest Tender/Quotation and reserves the right to withdraw the offer or cancel the tender without assigning any reasons whatsoever.
