The Container Freight Station of M/s. Continental Warehousing Corporation (Nhava Sheva) Ltd. located at Village Khopta, Taluka Uran, Dist. Raigad, Maharashtra was declared as a Customs Area under section 8 of the Customs Act, 1962 vide notification No. 01/2006 dated 12.01.2006 and M/s. Continental Warehousing Corporation (Nhava Sheva) Ltd. was appointed as a Custodian vide notification No. 02/2006 dated 12.01.2006. M/s. Continental Warehousing Corporation (Nhava Sheva) Ltd. was again appointed as a Custodian vide Notification No. 03/2010 dated 14.01.2010 for a duration of 5 years under the provisions of “Handling of Cargo in Customs Areas Regulations 2009”.

Now, in exercise of the powers conferred on me under section 45 (1) and 141 (2) of the Customs Act, 1962, I, S.H. Hasan, Commissioner of Customs (General), Jawaharlal Nehru Custom House, Mumbai Zone II, Nhava Sheva hereby appoint M/s. Continental Warehousing Corporation (Nhava Sheva) Ltd. to be the ‘Custodian’ of the Imported goods received at the Container Freight Station of M/s. Continental Warehousing Corporation (Nhava Sheva) Ltd.. until these are cleared for home consumption or are warehoused or are transshipped in accordance with the provisions of Chapter VIII of the Customs Act, 1962. Similarly, M/s. Continental Warehousing Corporation (Nhava Sheva) Ltd. will also be the ‘Custodian’ of the Export cargo brought into said Container Freight Station for examination and stuffing till their exportation through Jawaharlal Nehru Port.

Further, in exercise of the powers conferred on me under Regulation 10 of the “Handling of Cargo in Customs Area Regulations, 2009”, I, S.H. Hasan Commissioner of Customs (General) hereby approve M/s. Continental Warehousing Corporation (Nhava Sheva) Ltd.. as a “Customs Cargo Service Provider” for the said CFS M/s. Continental Warehousing Corporation (Nhava Sheva) Ltd. subject to following conditions:

1. The Custodian M/s. Continental Warehousing Corporation (Nhava Sheva) Ltd. approved as Customs Cargo Service Provider for the said CFS shall abide by all the provisions of the Customs Act, 1962 and the rules of the “Handling of Cargo in Customs Area Regulations, 2009”, other regulations, notifications, orders issued there under.

2.The duration of the appointment of M/s. Continental Warehousing Corporation (Nhava Sheva) Ltd.. as ‘Custodian’ and as “Customs Cargo Service Provider” shall remain for five (5) years from 14.01.2015.

3.The Commissioner of Customs (General) shall have the Right to review the approval as ‘Customs Cargo Service Provider’ before the completion of five years for failure to comply with any of the regulations of the “Handling of Cargo in Customs Area Regulations, 2009”.
