The ICC shall prepare an Annual Report giving full account of the activities carried out by it during the year and forward copy of the same to Chief Commissioner of Customs, Mumbai Zone-II for information and necessary action, if any. Further, Any woman facing sexual harassments at work place can register her complaint through <u>SHe Box portal</u> also.
