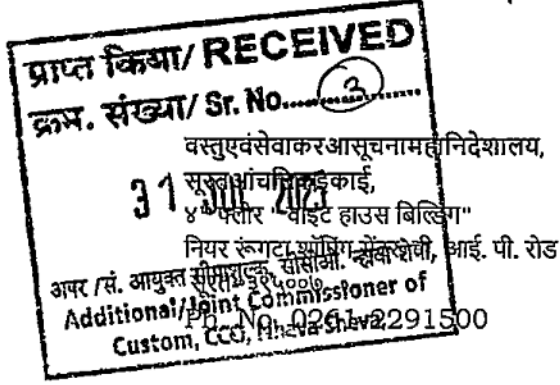

Subject: Preparation of panel for post of Intelligence Officer on Deputation basis in Directorate General of GST Intelligence, SZU, Surat -reg.

The Directorate General of GST Intelligence, SZU, Surat is in the process of drawing up a panel of suitable officers for filling up vacancy in the grade of Intelligence Officer on **deputation basis**. There are 06 (six) existing vacancies including 02 (two) vacancies arising during the month of Nov-2025 in the grade of Intelligence Officer on deputation basis in Surat Zonal Unit and its regional units at Vapi & Vadodara.

2. It is requested that this vacancy circular may be brought to the notice of all formations under your jurisdiction and the application of willing officers may kindly be forwarded to this office. While forwarding the name of the willing officers, it is requested that the following information in respect of officer may also be sent for the purpose of evaluation of their suitability for this Directorate:

- Willingness of the officer with complete Bio-Data
- History of posting
- ACR/APAR grading for the last 05 years
- Vigilance clearance & integrity certificate
- No Objection Certificate from Chief Commissioner's Office to relieve in the event of selection of the officer.

3. The period of deputation shall ordinarily be for 03 years and may be extended as per the extant Instructions/Rules.

4. It may be made clear to the willing officer that the option once given would be final and in event of selection, he/she will not be allowed to withdraw the same.

5. In case, while working in this directorate, if the conduct and work of the officer is not found satisfactory, the officer will be reverted to parent Commissionerate prematurely without assigning any reason whatsoever.
6. Willing officer may submit their application through proper channel on or before **10.08.2025**. They may however, send advance copy of willingness/application addressed to The Additional Director General, DGGI, SZU, Surat, 4th floor, White House, Building, Near Roongta Shopping Center, VIP Road, Vesu, Surat – 395007 or on Email ID: adm-dggiszu@gov.in
